



# Run Timing — Kenai, Soldotna, Homer

Peak of the run is in the middle of the dates given

<b>Kenai River</b>	King Salmon	Early run: mid-May to early July. Late run: early July to season closure late July or early August.
	Red Salmon	Mid-July to mid-August.
	Silver Salmon	Late July to late September.
<b>Russian River</b>	Red Salmon	Early run: mid-June to mid-July Late run: mid-July to season closure late August.
<b>Kasilof River</b>	King Salmon	Late May to season closure late July.
	Red Salmon	June through August.
	Silver Salmon	Late July through September.
<b>Anchor River, Deep Creek Ninilchik River</b>	King Salmon	Late May to mid-June.
	Silver Salmon	Early August to mid-September
<b>Anchor River</b>	Steelhead Trout	Mid-August to early November (catch-and-release only)
<b>Deep Creek Salt Water</b>	King Salmon	Early run: early May to late June Late run: late June to early August
<b>Homer Spit</b>	King Salmon	Mid-May to early July
	Silver Salmon	Early run: Mid-July to early August Late run: Early August to mid-September
	Dolly Varden	Mid-May to mid-July
<b>Halibut Cove</b>	King Salmon	Mid-May to early July
<b>Clam Gulch, Deep Creek, and Polly Creek</b>	Razor Clams	All year, on minus-2 foot tides or lower.

These streams all have regulations affecting tackle, hours open to fishing, areas open to fishing, and bag limits. Check the regulations BEFORE going fishing!
